Upcoming Changes - 1st October 2023

In 2022, Education Ministers agreed to changes to the National Quality Framework based on findings from the 2019 NQF Review. The 2019 NQF Review included extensive consultation with the sector, families and other parts of the community which informed government decisions. Decisions borne from this consultative process have led to the upcoming changes that will help ensure improved oversight, new safety and workforce requirements within FDC, to achieve better compliance and improved quality, and to ensure the safety, health and wellbeing of children in education and care.

NQF -Legislative Requirements for Family Day Care Educators - From 1st October 2023

We are pleased to confirm that there are only a small number of steps to be taken by you to meet these new upcoming obligation and requirements from 1st October 2023.

- 1. Revised RMP's replacement template (mandatory)
- 2. Updated Enhance Policies and Procedures See Enhance Policy Handbook
- 3. Residential Floor Plan / Evacuation Map (mandatory)

4. Daily Safety Cleaning Checklist – replacement template (mandatory)

Risk Management Plan (RMP)

With the changes coming into affect from 1st October a review of the current risk management plan template was completed to improve the functionality of the form. New Risk Management Plans will need to be completed by 29th September 2023 to be in affect from 1st October 2023.

FDC Residential Floor Plan / Evacuation Plan

In line with the upcoming NQF changes all current evacuation maps will need to be adapted to include the newly required information or alternatively the creation of a new and additional floor plan of your property will need to be displayed. The new requirements require a floor plan or map of the FDC residence to be displayed where accessible and easily visible for all families and visitors to your Service. The new or amended floor plan or map must display: the approved area where childcare is provided, all unapproved areas, Water hazards, fence line / boundaries, exit and entry points including emergency meeting points and first aid plus fire aids location. We have created a simple and easy template to help with this new display requirement. Please place on display and provide a copy of your

new residential map via email to your Practice Mentor by 29th September for review and filing.
